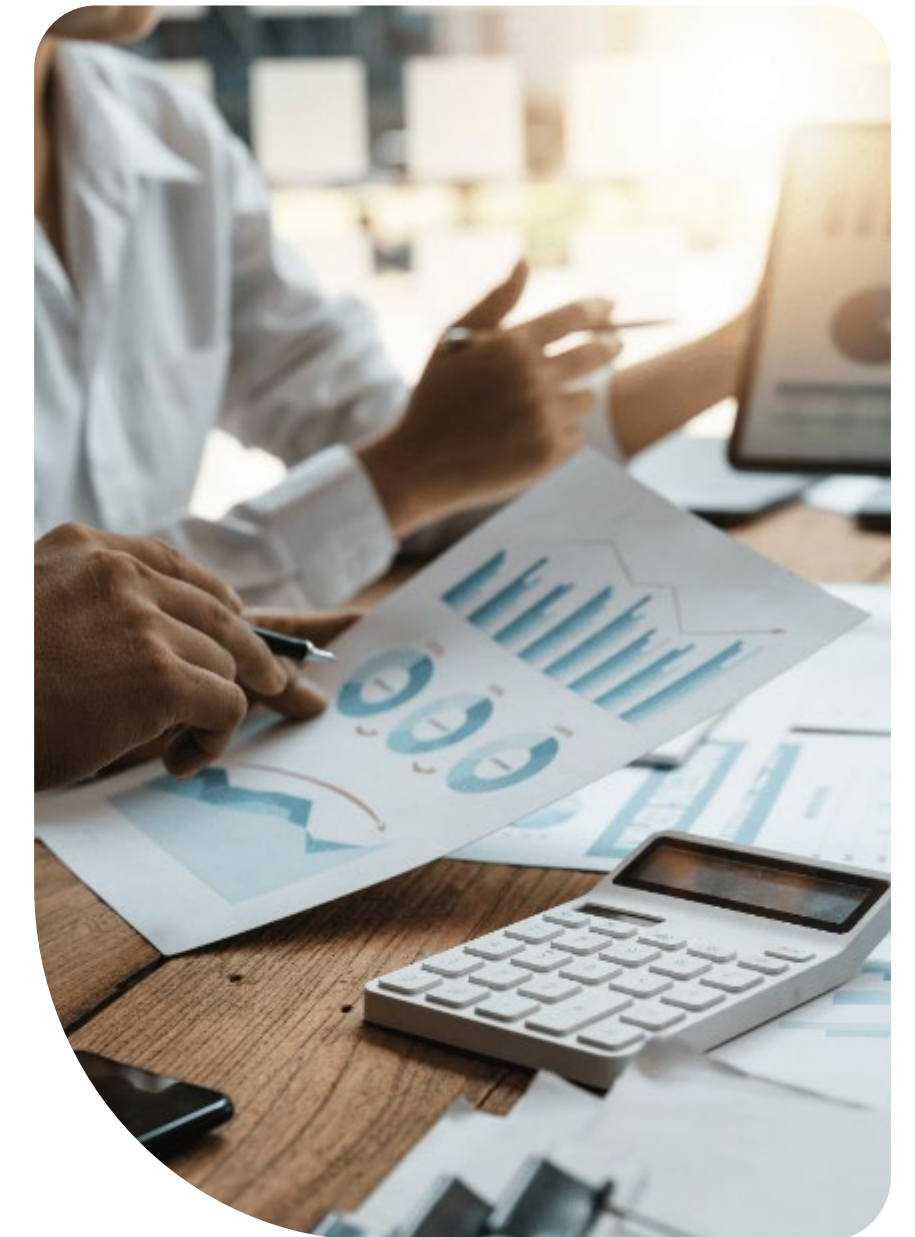
During the recent years, the GCC region has seen a 360-degree shift in its tax landscape.

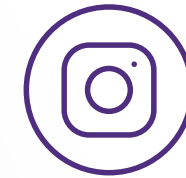
