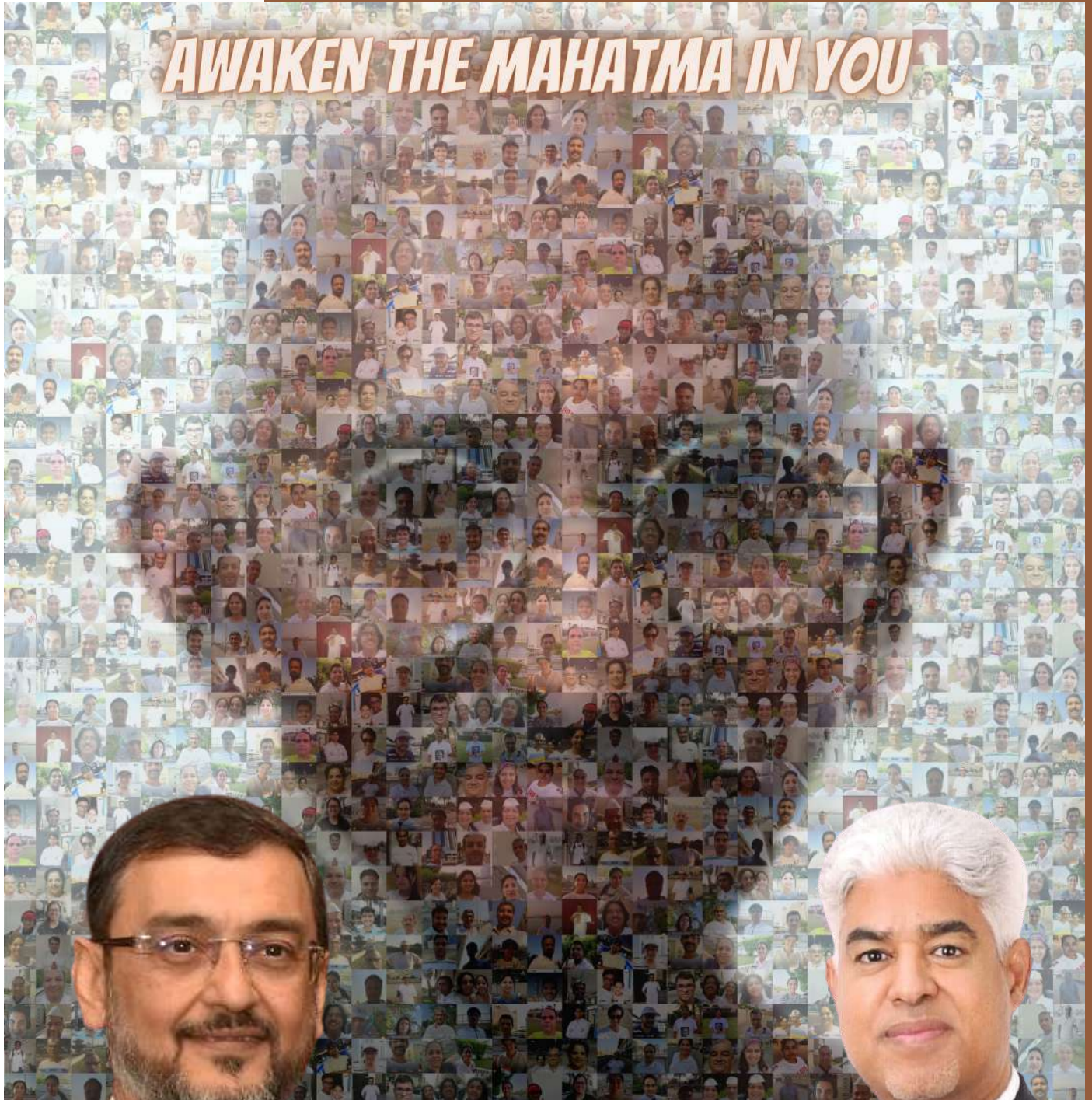

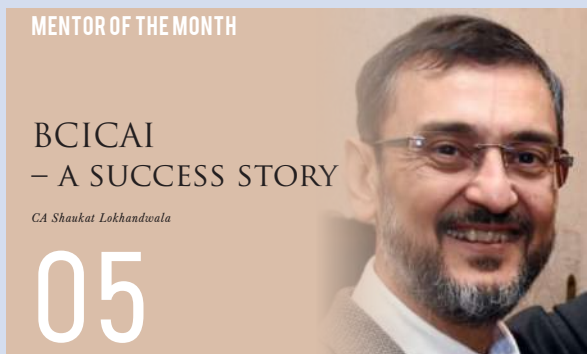

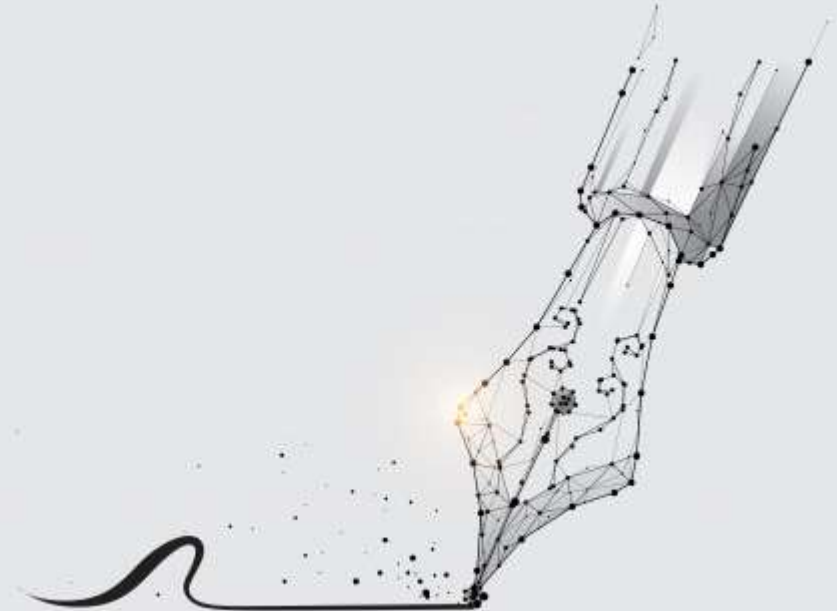

## MEET THE TITANS

**JASSIM ABDULAAL**  
GT Managing Partner

*We bring you an exclusive interview with the Titan of the month- Jassim Abdulaal (JA) GT Managing Partner, in conversation with our excommemember Vinit Maroo (VM) as he talks about leadership, work life and BCICAI.*

**VM: The pinnacle in an audit and advisory career is having your name as the brand name of your business, as a managing partner of GT Abdulaal, what are the bright sides and challenges of having your name as a brand name?**

**JA:** Having my name as a brand name is a big responsibility to me, we have worked very hard to create this name and reputation in the market today. It is years of service, especially having the Grand Thornton association has given us more responsibility to maintain and carry forward this name.

We have to meet the expectations of the clients, regulators as well as our internal expectations. We are the leading accounting firm in Bahrain and I assure that we keep our quality of deliverables very high and there should be no compromise in that.

Today we have reached a staff size of 120 employees, so we have a responsibility to have a sustainable business and a plan to grow and develop. We perform various services ranging from audit, advisory, special practice, taxation, IT, legal and corporate services.

**VM: Can you walk us through your early life and education?**

**JA:** I came from Malkiya village which I am very proud of. I grew up in a large family, I was a good student and was dedicated to my education. I started working very young to support myself, I started working when I

was 13, I worked as a fisherman when I was 14, we had a big boat, we caught fish, we sold the fish and made some money and saved it for the rest of the year. I also worked as a construction worker as a labour, This was my childhood.

From early schooling, Maths was my favorite subject, Maths teacher was my favorite teacher who influenced my love of accounting. When I completed my school, I was lucky to get a sponsorship to study in the UK, I did my accounting degree and my Chartered Accountancy from ICAEW.

**VM: Can you please elaborate about your early career?**

**JA:** After finishing my accounting degree in the UK, I started working with Coopers and Lybrands (which later became PWC). I started preparing for the Chartered Accountancy from ICAEW as CA from Bahraini Accounting Association was not that prevalent at that time. My early days of career were very busy, I was working and studying at the same time and during those years I got married also, these all happen in the UK.

Then I came to Bahrain, and I joined Cooper Jawad Habib. In a few years, we (a part of Copper Jawad Habib) separated and became part of BDO. In 2002, I decided to join politics and start my own practice. I was interested in Politics from the UK days following with politics, news, and world affairs.

**VM: From Chartered Accountant to Politician, How did that transition happen?**

**JA:** I stood for election for a seat in Bahrain parliament in 2002, I was the first chartered accountant to be elected as a member of parliament and I guess the only CA to be elected in Bahrain parliament.

I strongly believe in community welfare and that made me enter into politics.

I was part of the Economic committee of the parliament, and I am proud of my contribution to Bahrain and the community as Parliamentarian. My experience in the private sector helped me a lot in forming policies and procedures in government.

At the end of my term in 2006, I felt I want to join the profession again, I felt I can generate more value being in the profession again.

**VM: Is that the Birth of GT Abdulaal?**

**JA:** As I mentioned in 2006 after my political career, I decided to join the profession again, there was a small firm called Gulf Audit, there was nobody to manage it, I took over the firm and started building the practice and I was lucky to have a good team, Grant Thornton was also keen to enter Bahrain and we decided to work together as GT Abdulaal.

It is a joint success as it was possible because of my partners especially Jatin Karia who joined us soon after I started the firm.

We worked very hard to grow the business. Our training background, professionalism, technical knowledge won the trust of the clients and helped us in growing and maintaining our clients. We always believe in quality and client service and following these principles. We grew from a 8 member staff firm to 120 member staff firm providing multidisciplinary services, we are not a traditional accounting firm and are growing into more specialised fields. My performance in parliament, the respect I earned from the business community helped me immensely in the practice.

**VM: How do you ensure client satisfaction?**

**JA:** I am known as a professional, not as a businessman. Professionalism based on trust, dedication, and confidentiality goes a long way in client satisfaction. This profession is similar to the medical profession, you need a high level of ethics and integrity to win the trust of the client.

We don't do marketing, most of our clients come from the feedback from our existing clients, this kind of

feedback from clients really motivates us to perform better and ensure client satisfaction.

When client's do the marketing for you, you know that you are doing right.

**VM: In your position where you have grown from 8 people to 120 people, you get to hear of many opportunities and talents. How do you identify music from the noise?**

**JA:** Of course we need to prioritise music from the noise, priority is driven from the knowledge of the market. The understanding of the market enables me to make the decision.

We have to seize the opportunities presented to us and marshal our capabilities, we strive to deliver all our deliverables with high-quality standards, and where we feel that we have to compromise on quality, we abstain from the job. We are not rushing, we do not take shortcuts, we build long term relationships.

We invest in our team, we have highly qualified people who have consistently delivered results. Experience teaches you to differentiate music from the noise.

Our job is not an easy job, it's a demanding profession, we are not traders, It is a service which requires knowledge and experience and it also requires trust, interpersonal skills, responsibilities, and confidence to succeed.

**VM: Coming to a previous answer where you mentioned you worked in the UK in your formative years and then came to Bahrain, what are unique points you noticed in working in Bahrain ?**

**JA:** You learn things by observation and practice, I learned a great deal of knowledge in the UK. The approach which I developed in the UK, I follow a similar approach now also in handling things on the professional front.

A note-worthy point in the Bahrain market is the personal relationship you develop with the clients. It is not just the money we work for, the personal relationship and personal service you develop with your client is beyond fees, it's trust, quality and longevity of clients which we earn and want to earn. And we have inculcated this in our approach while delivering our services.

Having said that, professionalism, objectivity, independence are always there. They are non-negotiable, we don't compromise on quality. You have to be fair and objective and that is what earns the client's respect.

I can say that I learned professionalism from Europe and maintaining relationships from Bahrain.

We don't say that "send us an email", "send us a letter", "let me check my diary" to our clients, we are just a call away for our clients, I will change my lunch plan and plan a meeting with our clients to solve their problems. Clients are not customers, they are our partners.

**VM: From Fisherman to Managing partner in GT Abdulaal and executive position in so many listed companies, what is your mantra to success?**

**JA:** Invest in yourself.

Knowledge, Good memory, Technical expertise, being practical, and serving clients to best of their interest, these are the assets that have helped me immensely in building reputation and trust amongst my clients, The above-mentioned assets are visible when we serve our clients and then they value you. This has helped us in becoming a trustable name in the eyes of clients, the regulators, and my team.

Discipline, Committed, Hard Work, Fairness are the mantras to success.

I am a religious person, I strongly believe in self-discipline and community welfare. My experience in politics also taught me a lot to deal with people with fairness and honesty. I have 120 people in GT Abdulaal and I have never discriminated against them on any basis. I am part of various dispute resolution boards and you have to be fair in tough situations.

Gain and loss do not affect my mood. Whatever written in my name will come to me, that's the belief and all mighty Allah will guide us.

**VM: What's your advice to BCICAI to improve and Log in to the future?**

**JF:** BCICAI's role in Bahrain is very noticeable. We can see it from the events and activities they have organized, it's really remarkable. They have played and are playing an instrumental role in serving the finance and commerce community of Bahrain.

I feel if they(BCICAI) can go beyond Indian CA community and help young Bahraini professionals, that will be really nice. They can guide young Bahraini professionals on technical knowledge, professionalism and other virtues of this profession. I





know they have limitations, many responsibilities, and defined objectives but may be opening to the local accounting bodies will be a nice gesture.

**VM: What's the best way to reach young Bahraini professionals?**

**JA:** You can go to the universities, school, collaborate with Bahrain Accounting Chapter to plant the seed at the very starting . You can also reach the Business communities of Bahrain. I think that can be a good start.

**VM. COVID 19 is the biggest crisis of our time, what's your biggest learning out of this?**

**JA:** It's a difficult time for all and we don't know when it will end but it will take a while for things to normalize. People have to take the necessary precautions but also adapt and get used to it.

COVID 19 has changed the world, and I can see the social and cultural change in the people but we will overcome this soon. We should have faith in our creator, that everything will be fine in the end and then everything will be fine.

I pray that this pandemic can reduce the boundaries between the countries, this pandemic has hit the world, no country is immune to this virus, all the countries have to unite to fight against this pandemic. The countries should forget the political and regional conflicts and think of ways to collaborate and fight against COVID-19.

### **Biggest learning:**

Technology and Automation.

You have to adapt and find out the best practices to run the business. The use of technology has accelerated in the pandemic. Remote education, remote working are radical ideas, and as a business, we have adapted and embraced it in pandemic. COVID 19 has brought various business and economic challenges to the industry.

The businesses which are open to technology and automation will not only survive but thrive in this pandemic.

## BCICAI COMMITMENT PROGRAM

Commitment Program is a new initiative launched by the BCICAI Executive Committee ("Excom") with the objective of promoting inclusiveness and adding value to the members. Under this program, Commitment points will be given to the members for their participation in technical events and certain other events as will be announced by the Excom. The main objectives of the program are:

- Encourage more participation by members in the technical events of the Chapter
- Reward the commitment of members who take time to attend Chapter's technical events

### Will Commitment points have monetary value

It is not intended to assign monetary value. In case of there being a balance of Commitment points at the end of the term, it will be decided in consultation with the incoming Chairperson if this can be carried forward. If not, decision will be taken on how to reward the members with the points which may include assigning monetary value

### Validity

The plan is to have it only for online events. The decision on commitment points for physical events will be taken once BCICAI is in a position to resume the Physical events

### Awarding Commitment Points

Commitment points will be credited for

- Attending Chapter's technical events (#)
- Certain events will carry double points which will be announced before the event.
- Participating in Q&A during technical event
- Taking up roles or volunteering in chapter events.
- Joining ICAB Toastmasters club, C2A club or enrolling for Speechcraft.

# The attendance will be validated using the attendance reports from the meeting platform and that will be the final basis for deciding eligibility i.e. minimum one-hour attendance. Members should use same email id to login in case they are disconnected during an event so that the attendance minutes can be cumulated

### Check accumulated Commitment points

On a monthly basis, an email will be sent to members with their points statement showing opening balance, credited, utilized and closing balance of the Commitment points. The email will be sent to the email ID that is provided by the member in the Member database. It is the responsibility of member to ensure the information is up to date on the Database. Members will have 7 days from date of receipt of statement to raise any queries relating to the details on the Statement.

### Commitment Points Usage

There will be a number of avenues which will be announced periodically for using the Commitment points.

Some of the common examples are:

- Access to the online digital library
- Use for some specific workshops such as Excel, etc which will be accessible exclusively using Commitment points
- Some Chapter branded assets such as T-shirts can be acquired using Commitment points
- Exclusive groups may be set up which can be accessed using Commitment points
- Sports facilities may be rented out by BCICAI which can be used by members using Commitment points

An easy way to add return to your portfolio is to OPTION SELLING. Option selling is not considered by many as margin requirement is high. Also because of the myth that option selling entails unlimited risk. But risk management is the key to success in any form of business.

## How to do in an easy way:

1. Research and buy a stock which you are convinced will do well in next one year or so. It should be in F&O segment as well
2. Buy equivalent lot of stock matching to F&O
3. Now set a profit target of your choice eg 10%. Add to the value of the stock and sell the CALL OPTION near to the target price (strike price) of the same month.
4. Collect the premium. Now the stock will have 2 scenarios
  - a) Price never touches strike price then premium collected is your profit
  - b) If price rise more than your strike price sell the stock at the higher price and square the call. Premium collected is your additional gain.
5. If you are out of that stock search new ideas
6. If the price was in the range sell next month Option call and repeat till you are out from the stock.

## Illustration

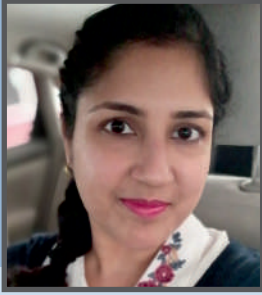
Buy UPL 1300@550. Now adding 10% will give you range of 55. So sell a call option of 610 for 10-11 range and wait. If the price never reaches 610 you pocket the premium. If price goes more than 621(610+11) sell the full stock and cover your sell position as well. If the price does not reach 610 sell next month call.

## Risk

This is risk free strategy. Only loss is when the stock suddenly jumps say it becomes 650 and your profit is restricted to 621 in above example. But you got more than your target price.

If the price of stock goes down you will still be able sell options near your cost price and next time try to improve your selection.

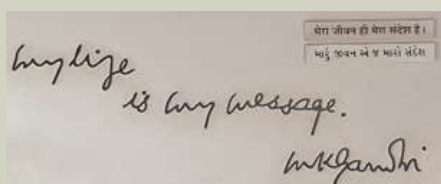

# Is guidance from the NBR relief for the industries?

On 01.01.2019, Kingdom of Bahrain ('Kingdom'/'Bahrain') became the 3rd country in GCC and 167th in the world to employ Value Added Tax ('VAT'). Almost 7 quarters have passed since VAT was introduced, yet, it is one of the most prominent topics in the Kingdom.

Before the implementation, there was lot of deliberation as to the preparedness of the companies and the country as a whole as regards the smooth alignment into VAT. However, with the decision to bring only few large corporations under the VAT ambit from 01.01.2019 and giving leeway for small and medium enterprises somehow gave way for Kingdom to adapt to VAT.

National Bureau for Revenue ('NBR'/'Bureau') is the government body created solely for implementation and administration of VAT in the Kingdom. From organizing regular sector specific workshops to assigning dedicated relationship managers to businesses, NBR has taken several steps to ensure that businesses face minimal issues and smoothly transit into the new regime. One such step is throwing light on various critical issues by way of providing clarifications in the guides.

NBR has come up with eighteen guides out of which eight are in relation to specific industry/sector viz. real estate, banking, insurance, education, healthcare, etc. Additionally, five public clarifications have been issued to clear the mist of differential VAT treatments by travel agents, non-executive directors, etc.

One of the most difficult conundrums for the businesses and consultants is always to interpret the law in a manner which is intended by the tax authorities. The VAT General Guide issued by NBR covered the gamut of provisions of Law and Regulations (from registration to how invoices are

prepared) in a laymen language while highlighting certain common issues. The additional sector specific guides issued subsequently acted as an icing on the cake and proved valuable for businesses in deciphering certain grey areas and direct the implementation efforts in a manner consistent with law.

However, the guides do pose certain questions and I have summarized some of them below, based on my experience of providing VAT Implementation, Advisory and Compliance services to some of the leading businesses in Bahrain.

## **Whether the clarifications provided in the guides are binding on the tax authorities?**

Article 114 of Bahrain VAT Executive Regulations provides that the Chief Executive Officer of the Bureau shall issue explanatory guides, instructions and explanations necessary for the application of the provisions of the Law and the Executive Regulations to which the Bureau shall adhere, and the taxable person shall rely and use these as guidance when applying the provisions of the Law and these Regulations.

In view of above provision, businesses should consider the guidance provided in the guides in assessing their compliance with VAT obligations.

However, in Section 1.1 of each guide, it is stated that the guide is not a legally binding document and does not commit the NBR or any taxpayer in respect of any transaction. This document should be used as a guideline only and is not a substitute for obtaining competent legal advice from a qualified professional.

What remains to be seen is whether businesses will be able to take shelter of the guides in case tax authorities adopt different view than what is mentioned in the guides!

### Whether the clarifications provided in the guides are in line with the provisions of Law and Regulations?

The guides state that they are intended to provide general information only and contain the current views of the NBR on its subject matter. No responsibility is assumed for the VAT laws, rules or regulations in the Kingdom of Bahrain.

### Does the guide cover all the instances where grey areas exist?

Although the guides appear to be meticulously drafted, there are certain instances which are very nuanced to the specific industry and may warrant a deeper evaluation. Thus, although the guides seek to provide clarity on some of the aspects pertaining to a specific scenario/ industry, 100% coverage is very ambitious to expect. For example,

- Education Booklet:
- Clarification provided by NBR:

Schools can take credit on the goods and services provided free of cost to the students.

### Issue:

Wouldn't the provision of deemed supply play a role in this case and ideally school will be required to either not claim VAT or pay VAT on notional value of such free of cost supplies?

Though Bahrain VAT is in evolving stages and businesses are still adapting to the change, yet, there is an immediate need to streamline the tax positions before the on-ground audits are initiated. Considering Bahrain has the highest penalties laid out in the Law itself, it is imperative for businesses to obtain a professional evaluation on sensitive matters to mitigate the chances of adverse repercussions in future.

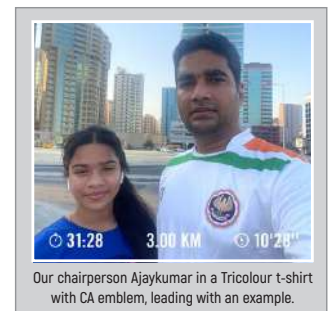
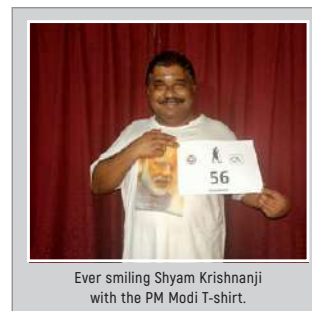
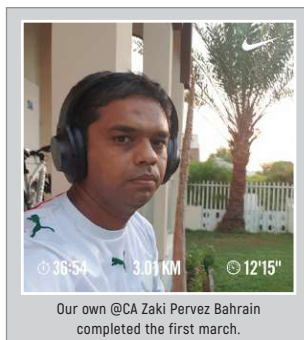
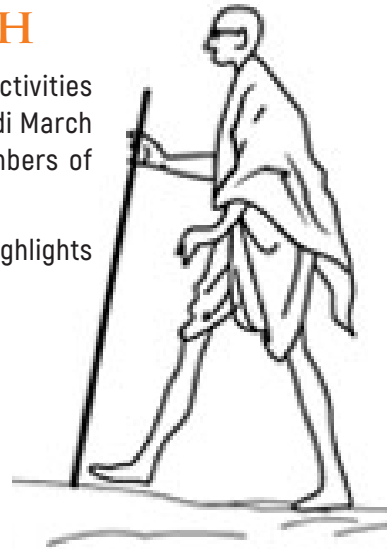
Encouragement and appreciation from the participants were amazing and below are the highlights that confirm it.

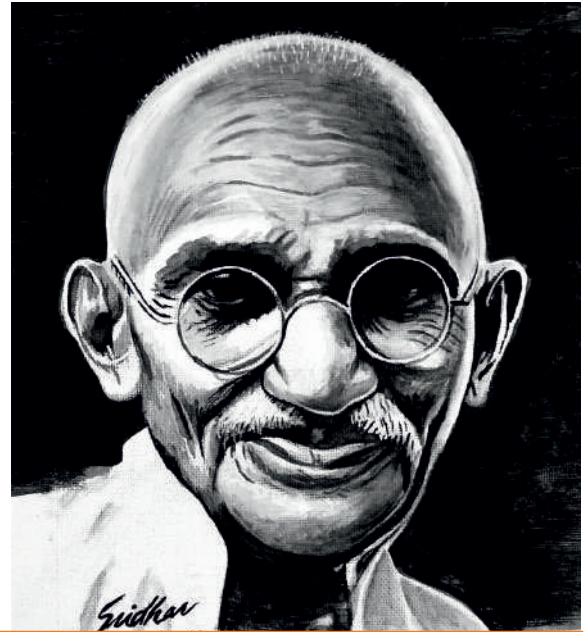
## Children Arts Workshop - Gandhiji Portrait

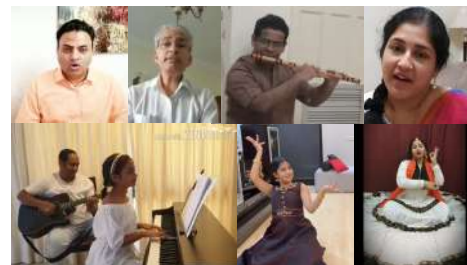
## Howz the Josh performances

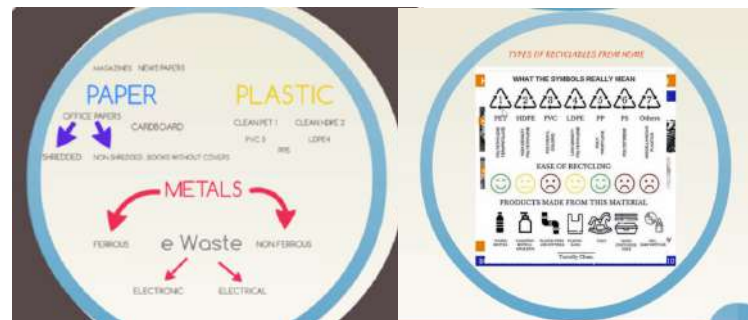

## ICAI Global Week: Promoting Accounting and Financial Service Globally

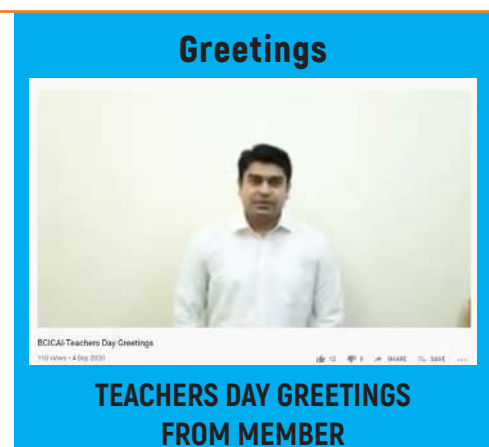

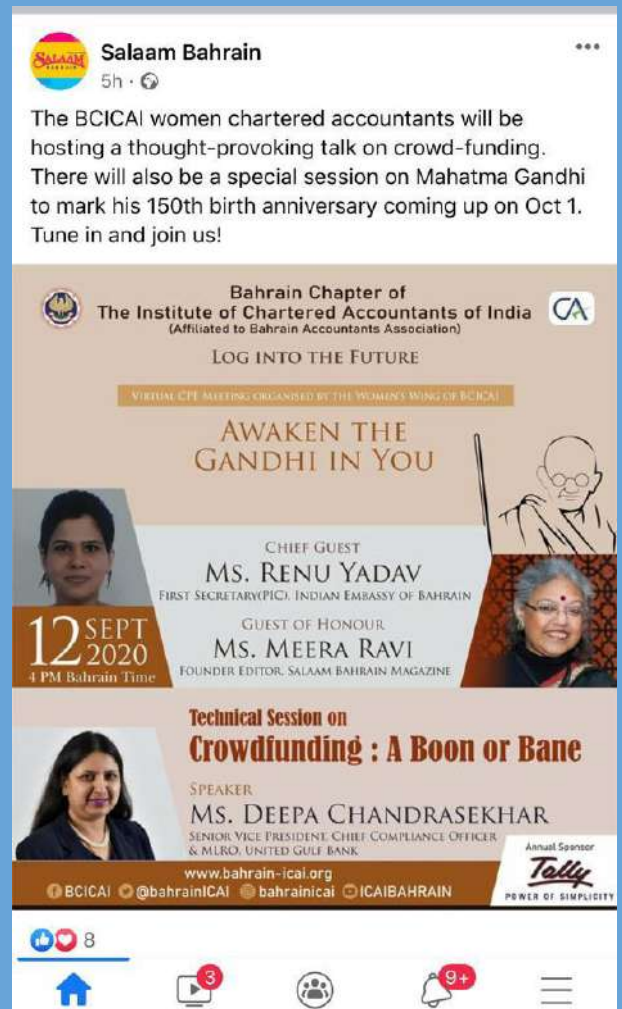

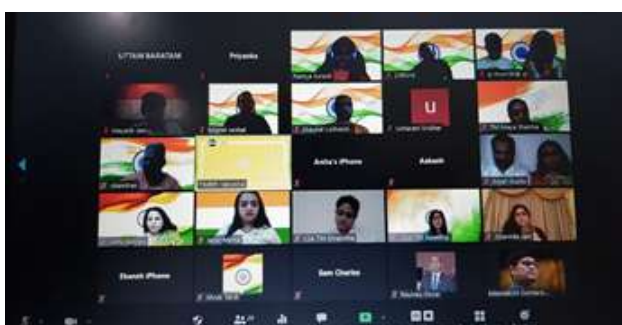


## August 12th 2020 Theme: Independence Theme

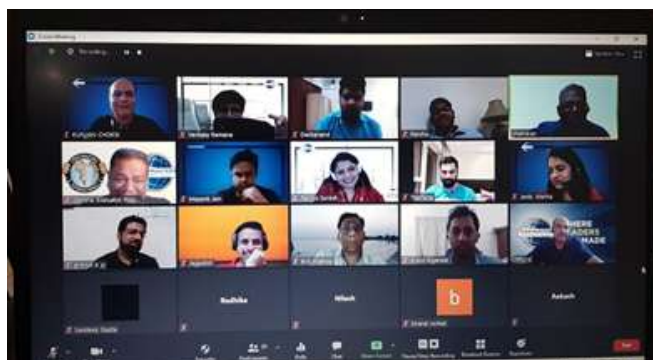
One line stories also has the same impact as the long stories. Some stories make you turn pages and pages in sweet anticipation, while there are others that tell so much in a single sentence.

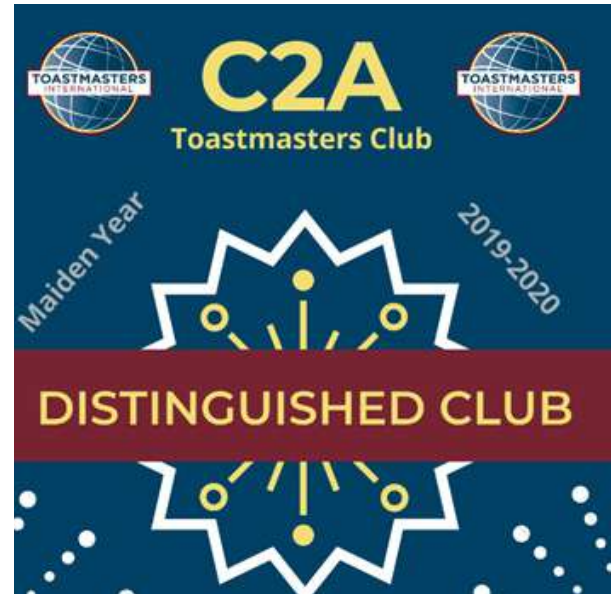

# Recipes

## Dabeli

### Ingredients

- 3 nos – Potatoes (boiled and mashed)
- 4 nos. – Indian Pav (bun bread)
- 2 Tbsp – Oil
- 1 pinch – Asafoetida
- 1 tsp – Turmeric Powder
- 1 tsp – Kashmiri Red Chili Powder
- 3 tsp – Dabeli Masala
- Salt to taste
- Tamarind & Dates Chutney (Imli chutney) [to apply]
- Garlic Chutney [to apply]
- For garnishing – pomegranate, fresh coriander, fresh coconut,
- 1 small onion finely cut and blanched peanuts, nylon sev

### Garlic Chutney

- 8-10 garlic cloves
- 1 tsp coriander powder
- 1 tsp Kashmiri Red Chili Powder
- A pinch of Hing
- $\frac{1}{2}$  tsp oil
- Salt to taste. Water as needed to grind

### Dabeli Masala

- 4 tsp – coriander seeds
- $\frac{1}{2}$  tsp – cumin seeds
- 1 tsp – sesame seeds
- 1 tsp – fennel seeds
- 4-5 cloves
- 1 tsp whole black pepper
- 1 tsp – tamarind
- 2 – cinnamon sticks
- 2 – bay leaves
- 1 – star anise
- 4 tsp – Kashmiri Red Chili powder
- 1 tsp – black salt (kala namak)
- 1 tsp – dry mango powder (amchur)
- 4 tsp – desiccated coconut
- 3 tsp – sugar

### Dabeli Masala

Dry roast all spices except Kashmiri red chilli powder, kala namak, amchur, dessicated coconut and sugar for 1-2 minutes till it turns aromatic and slightly changes color.

Add remaining spices and fry for a further half minute. Let cool.

Once it is completely cooled, grind to a coarse mixture. Take a cup of roasted peanuts, add salt, turmeric, 2 tbsp Kashmiri red chilli powder and oil. Mix well and keep aside.

### Garlic Chutney

Take the garlic cloves. Add pinch of hing, pinch of turmeric, 2 tbsp Kashmiri red chilli powder, little oil and grind to a fine mixture with little water.

### Dabeli

Heat 2 tsp oil to the same pan.

In a bowl of water add dabeli masala to form a thick mixture. Add to heated oil. Fry for 0.5-1 min

Add 2.5 potatoes, boiled and mashed. If the mixture appears too dry add 1-2 tsp water. Adjust salt as required.

Garnish with pomegranate, prepared masala peanuts, chopped onions and coriander leaves. Pat down the garnishing.

Fill the masala into a pav bread on one side. Spread garlic chutney and dates chutney on the other and roast on a pan with ghee/butter.

Garnish with nylon sev, pomegranate, onions and coriander leaves and enjoy!

# Kadak



## Ingredients

- 6 -8 nos toasted buns (readymade)
- 2 boiled potatoes – cut in small pieces
- 1 cup - Tomato Puree
- 2 Tbsp – Oil
- 1 tsp – Turmeric Powder
- 1 tsp – Kashmiri Red Chili Powder
- 1 Tbsp – Dabeli Masala
- Water as required
- Salt to taste
- For garnishing – Fresh Coriander, 1 small onion finely cut,
- blanched peanuts, tamarind & dates chutney, garlic chutney

## Method

Break bread toasts to pieces and set aside.  
Heat little oil in a pan. Add 1 small grated tomato. Fry until raw smell goes away.  
Add salt and a pinch of turmeric. Now add water.  
Add 2.5 tsp dry ground masala mix prepared for Dabeli. Stir and mix.  
Add boiled potatoes – 1 mashed and 1 in small pieces. Let cook for 2-3 mins until oil starts to separate from the sides.  
Pour onto the toast pieces.  
Garnish with masala peanuts, nylon sev, pomegranate, coconut, coriander leaves and chopped onions.  
Serve immediately.

# Khichu



## Ingredients

- 1 cup rice flour
- 2 1/2 cups water
- 1 tsp – cumin seeds
- 1 green chili – finely cut
- 1 inch – finely grated ginger
- 1 tsp – soda bicarbonate
- 1 tsp – oil
- Salt to taste
- For garnishing – oil, red chili powder or gun powder, fresh green coriander

## Method

Take water in a pot. Add ajwain, jeera, ginger, green chilli, pinch of hing and a pinch of turmeric.  
Bring to a boil.  
After a couple of mins, mix rice flour. Mix well immediately to avoid forming lumps.  
Microwave the mixture for 2 mins.  
Garnish with a generous serving oil, some red chilli powder and coriander leaves. Serve hot and enjoy!

## Tamarind Shots

### Ingredients

- 1 cup – Sweetened Tamarind Pulp
- 4 Tbsp – Masala Boondi (droplet sized crispy fried chickpea flour Indian snack)
- 2 tsp – black salt
- 1 tsp – red chili powder
- 1 tsp – roasted cumin powder
- 3 cups – chilled water

### Sweetened Tamarind Pulp

- 1 cup – tamarind (imli)
- 2 cups – sugar
- 1 tsp – black pepper
- 1 tsp – red chili powder
- 2 tsp – roasted cumin powder
- 2 tsp – salt

### For sweetened tamarind pulp

Soak the tamarind for an hour in water. Grind it. Add sugar and the spices to the tamarind paste and boil it well. Once cooled, refrigerate it and keep.

### For shots

Add one cup of sweetened tamarind pulp and one and a half cup of water. Add little salt, roasted jeera, black salt, and red chilli powder. Stir it well and keep it in the fridge to cool for 1 hour.

Add masala boondi to it before serving.  
Serve chilled and enjoy!



# Gatte ka Pulav



## Ingredients

### For Gatta:

- 1 1/2 cups – Chickpea Flour (Besan)
- 3/4 cup – ghee or oil
- 1 1/2 tsp – curd
- 1 tsp – red chili powder
- 1 tsp – cumin seeds
- Salt to taste

### For Pulao:

- 1 cup – basmati rice (pre-soaked in water)
- 1/2 cup – green peas
- 2 Tbsp – oil
- 2 cloves, 1 bay leaf, 1 black cardamom
- 1/2 2 Tbsp – raisins
- 2 Tbsp – cashews
- 1/4 tsp – cumin seeds
- 1/4 tsp – coriander seeds
- 1 tsp – red chili powder
- 2 tsp – coriander powder
- 1/4 tsp – turmeric
- 1/4 tsp – garam masala powder
- 1 pinch – Asafoetida
- For garnishing – few dry mint leaves, lemon juice, roasted papad

## Method

**For Gatta:** Take a bowl put besan in it, add ghee or oil as preferred with all masalas and mix well like a dough. If you need little water put little water mix well and make a long roll and cut into small pieces and fry and keep it aside.

Add oil or ghee to a pan and add whole Garam Masala and jeera along with peas.

After few minutes add Hing. Stir and add all the masalas – turmeric, coriander powder, garam masala, salt, red chilli powder, dry mint leaves, rice and mix it well. Add 2 and half cups of water and taste this water here for any flavors to be added.

When you see the water boiling you can now add the prepared gatta. Cover it for 5 to 10 minutes until the water evaporates.

Add lemon dry mint leaves and serve it with papad.



# Sattu

## Ingredients

- 1 cup – black roasted chickpeas (peeled)
- 1/2 cup – sugar powder
- 3/4 th cup – ghee
- 1/4 th cup chopped almonds
- For garnishing – cardamom powder and saffron

## Method

Take one cup of chana clean and remove skin completely. Roast in microwave for 2 minutes let them cool and grind in the mixer to make a powder. Now take a bowl add this chana powder with sugar, almonds and elaichi. Add half cup ghee to this and make it a tight dough. Mould into desired shapes. Add silver barak if you like and sweet dish is ready to serve!

Be the change, be the change....and see the change



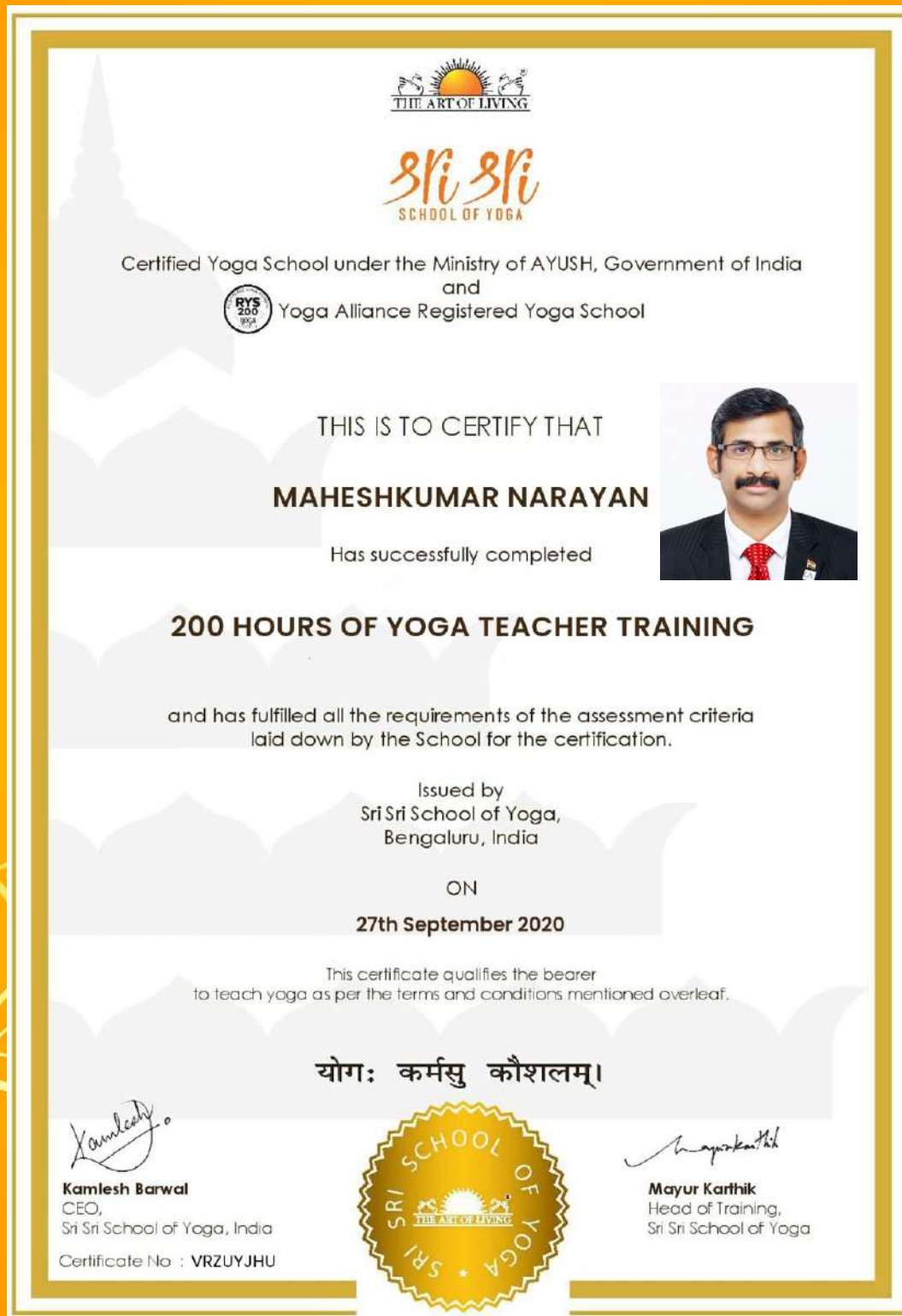

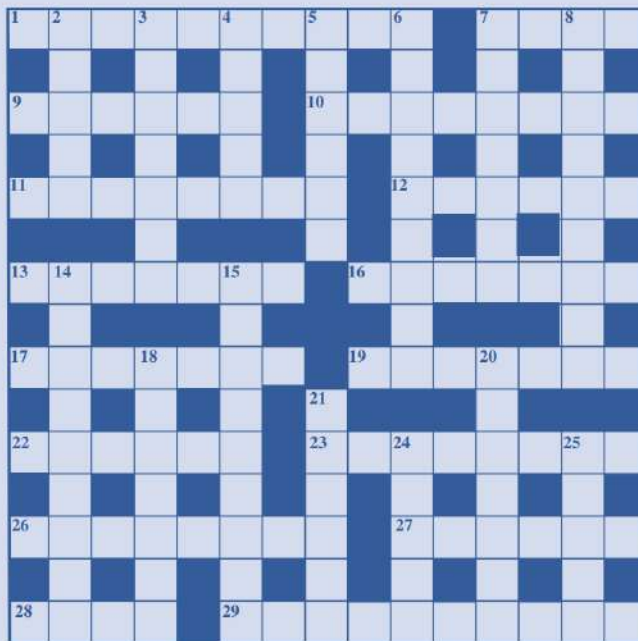

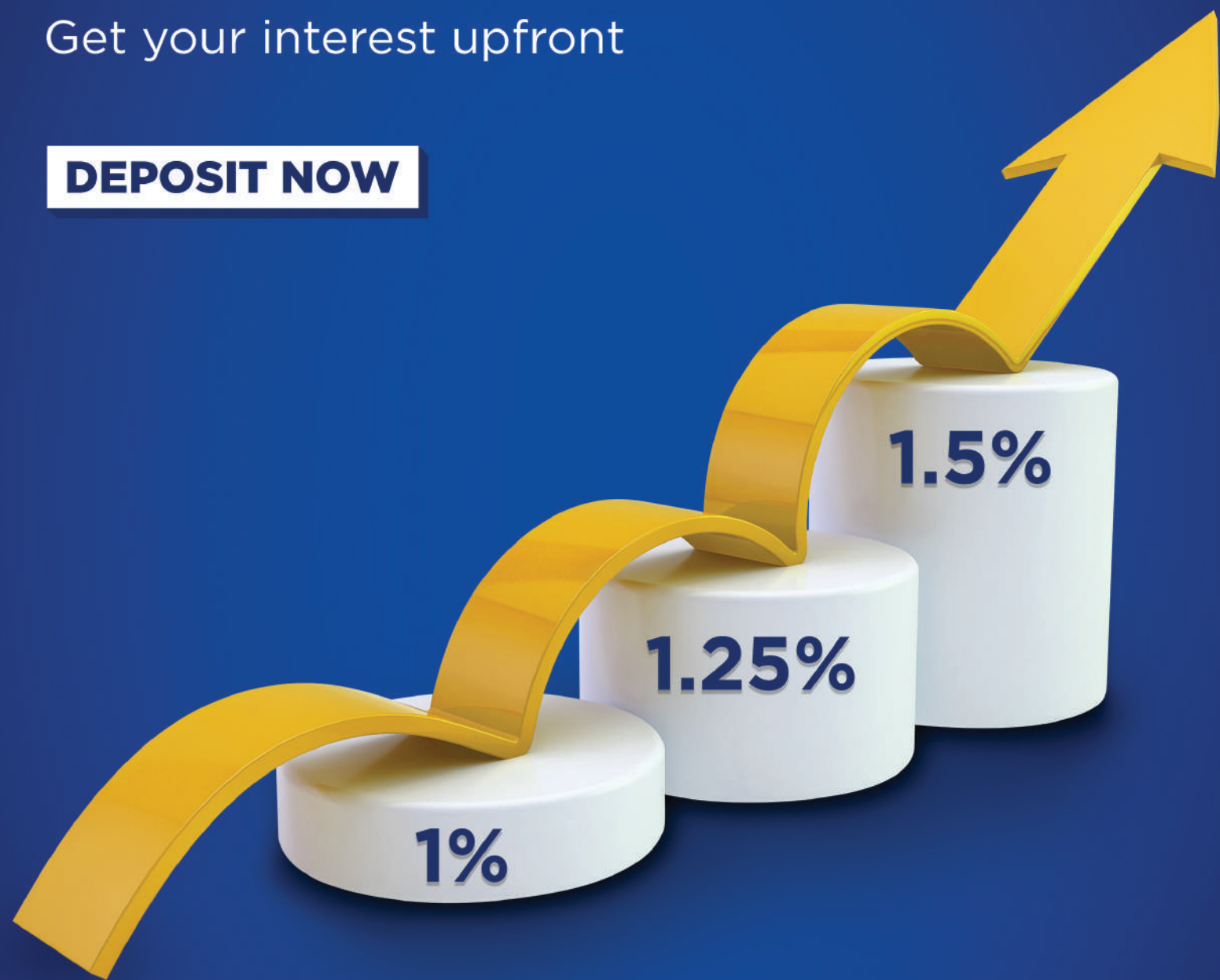
